5. That I have not been found or charged for my involvement in any kind of ragging in the past. However, I undertake to face disciplinary action/legal proceedings including expulsion from the University if the above statement is found to be untrue or the facts are concealed, at any stage in future.
6. That I shall not resort to ragging in any form at any place and shall abide by the rules/laws prescribed by the Apex Court, Government of India and the University Authorities for the purpose from time to time.
7. That in case the deponent is found guilty for an offence of ragging, he/she will be solely responsible for the legal as well as disciplinary/and administrative action taken by the University which may lead to rustication also.
8. That the deponent shall not make any claim against the action taken by the University, in case of guilty.
